I agree not to make claim against any person or corporation who might claim contribution or indemnity against the Church, its board of directors, agents, employees, officers, in connection with or arising out of, either directly or indirectly, the Mission Program and all related activities.

I am aware of and understand the risks, hazards and dangers inherent in the Mission Program and related activities, which include but are not limited to the possibility of personal injury, death, property damage or loss resulting therefrom, and travel to and from the location of the Mission Program. Notwithstanding the inherent risks, hazards, and dangers, I request the Church to allow me to participate in the Mission Program and all related activities and I hereby agree to assume all risks involved in engaging in such activities, including travel to and from the locations of operation.

I AGREE, and am aware, that as a condition of being allowed to participate in the Mission Program and all related activities, I do warrant that I am in good physical and mental health and that I will not consume alcoholic beverages or any other substances, such as would impair my senses, while participating in the Mission Program.

I HEREBY ACKNOWLEDGE that I have read this Agreement at my leisure and understand that it is a full and final release and waiver of all my claims for damages or injuries sustained as a result of my participation in the Mission Program and that I am voluntarily discharging the Church, its board of directors, agents, servants, employees, executors, administrators and successors and assigns from all liability for any losses and damages which I may sustain.
